 - iv) Being more creative and moving away from shotgun approach. PD meeting with county jail warden to discuss probation violations.
 - b) City Report:
 - i) City Planning office busiest it has been in seven years. Projects entering construction phase.
 - ii) Hilton Hotel proposal returning to DRC on Aug. 6. On track for approval by end of year.
 - iii) Mar-i-cel & Ashkar's Apartment projects in plan check. On track for construction in 2017.
